# 21/06/09 GM Annual Report and Accounts 2020

The General Meeting for Scotland Annual Report and examined Accounts for 2020 have been circulated with the papers for this meeting. They were approved by GM trustees at their meeting on 21st May 2021.

Nigel Dower, our treasurer, has presented the report and accounts, drawing out particular details and answering our questions.

We are grateful that much of the work on our concerns has continued online during the pandemic.

This is an unusual year - the figures are not entirely indicative of the state of our accounts. In 2020, as there was going to be an underspend because of the pandemic, trustees decided to return a percentage of the £10,000 AM quota to the AMs but 2 AMs transferred their rebates, totaling £1723.98, to offset their 2021 quota.

The vacant Parliamentary Engagement Officer's post was not filled until autumn 2020, because of the pandemic. Of the total £10,000, set aside for the Scottish AMs and GM contribution to the cost of the post, only £2500 was required in 2020. The remainder was vired across to 2021.

Total income for 2020 from area meeting quotas, grants and donations was £25,662.67 and payments amounted to £18,805.18, giving a surplus for the year of £6857.49, and a balance of £42,984.48. However, if the figures were adjusted to account for the money transferred to 2021, there would be a deficit of £2366.49, which is less than the budgeted deficit of £4000.

We receive and accept the General Meeting Report and Accounts 2020 and ask our clerk to sign them on our behalf.

We thank our trustees for their work and Nigel for his preparation and presentation of these documents.

# 21/06/10 General Meeting for Scotland Governing Document

Further to minute 21/03/15, local meetings in Scotland have been notified of the proposed updates and amendments to the GM Governing Document and no objection to these was raised.

We now agree the revised document.

# 21/06/11 Introducing Zoe Prosser, Local Development Worker in Scotland

Zoe has told us a little about herself and of how she intends to approach Quaker local development work in Scotland.

Before taking up this post, she worked for Britain Yearly Meeting, in various roles.

Zoe has spent her first six weeks joining in with some local meetings and getting to know our Quaker community in Scotland.

She is here to help us achieve our aims as Quakers in Scotland, and can help us build our skills, further our networks, and connect with people and resources. Her early plans are to offer elders support and

training and to work with Quaker activists involved in COP 26, connecting them to available help.

# 21/06/12 Parliamentary Engagement Working Group report

The report of the Parliamentary Engagement Working Group (PEWG) was circulated in advance of this meeting. Joyce Taylor has updated the report.

Our Parliamentary Engagement Officer, Andrew Tomlinson, has encouraged Friends and local meetings to send postcards to their new MSPs congratulating them on their election, sharing Quaker hopes for the future, and offering to support them in their work. Some Friends shared their positive replies. Local and area meetings will be asked to inform Richard Raggett of responses they receive.

The PEWG continues to make links with MSPs and Cabinet Secretaries and to raise issues of concern to Friends, including Scotland's role in weapons manufacture, and the planned firing range near Samye Ling Monastery, Eskdalemuir.

Collaborative work on COP26 continues.

We are pleased to hear that new work on peace education in Scottish schools is being explored with QPSW.

# 21/06/13 Parliamentary Engagement Officer post, future funding

We have received a paper explaining the need for transitional funding arrangements for this post, as it moves from joint funding by AMs and GM in Scotland and BYM, to a permanent BYM funded post.

We have heard that the contribution of the Parliamentary Engagement Officer is essential to looking after Quaker priorities, and that this work is much appreciated by other Scottish churches. To allow BYM to give an undertaking now that the post will be made permanent at the end of this year, AMs and GM are asked to underwrite a total of £10000 per year for three years, of which GM would underwrite £4000 per year. We have been given an assurance by our treasurer and trustees, that GM is financially able to give this undertaking. We give this commitment.

# 21/06/14 Meeting for Sufferings Report

We thank Ann Kerr for her written report of Meeting for Sufferings held on 10<sup>th</sup> April 2021, which was circulated with the papers for this meeting.

Ann also provided a brief written report of the Threshing Meeting held on 6<sup>th</sup> April 2021, in response to minute 21/03/16. The conclusion of the Threshing Meeting was that it was not appropriate to take any further action at this time. However, MfS representatives felt that it was valuable to meet together in advance of each Meeting for Sufferings.

# 21/06/15 Enquirers' Day 2021 – Exploring the Quaker Life

We thank Mariot Dallas for her written report of this event, which was circulated with the papers for this meeting. This year it was organised by South East Scotland Area Meeting and it took place by Zoom on 24<sup>th</sup> April. Twenty-one participants attended and feedback was positive. Organisers hope to hold a follow-up event.

# 21/06/16 Scottish Churches Housing Action

As one of the churches supporting Scottish Churches Housing Action (SCHA), we have received a letter from the Board asking if we wish SCHA to continue as an ecumenical voice on the issue of homelessness and if we do, what does our commitment involve. This enquiry was prompted by SCHA's current financial difficulties, including the discontinuation of a Scottish Government grant of £57000, from March 2022.

In General Meeting for Scotland's 2021 budget, we committed to contribute £500 to SCHA but to date we have not found a Friend willing to serve on the Board.

We discussed our future commitment to SCHA.

We agree that there is a need to tackle homelessness and in the past SCHA was an important organisation, which allowed the churches to respond to this issue. However, given SCHA's current financial struggle, and the difficulties churches are having in finding members to serve as trustees on the Board of SCHA, we doubt if it is still a viable organisation.

We think our concern for homelessness and poverty would be better channeled through our Scottish parliamentary engagement work, although this would require us to give it further support. Perhaps other churches could do likewise through their own parliamentary advocacy. From time to time, churches could gather together to explore issues around homelessness.

It is with a very heavy heart that we intimate our intention to terminate our membership of SCHA in March 2022.

We ask our clerk to write to the SCHA Board to inform them of our discussion and decision.

# 21/06/17 Hearing from GM representatives on bodies focused on social witness

General Meeting for Scotland extends its social witness through linking with organisations focused on specific issues. In preparation for this meeting we have received written reports from our representatives on the following bodies:

# Faith in Community Scotland (FiCS)

This predominantly Christian body supports and works alongside those living in poverty. Along with other funders, it set up a Rapid Response Project during the pandemic, to provide food and essentials for people in greatest need. Cuts to the funding of one part of the organisation, FiCS Action Fund (now Small Grants Committee), have led to its major grants programme being scaled back: it is now only offering small grants.

### Interfaith Group on Domestic Abuse

The Group raises awareness of the existence of domestic abuse in all parts of society, including the churches. Statistically, two women are killed each week in the UK, by their current or ex-partner. This is also a faith issue, as abuse in the home creates damage in the family, the community and society, violating God's wish for humanity. In 2011, GM endorsed the Scottish Interfaith statement on domestic abuse.

# Scottish Faith Action for Refugees (SFAR)

SFAR advocates on behalf of refugees and asylum seekers and encourages supportive action and a spiritual response from the churches to these issues. It provides good resources and assistance for those involved in refugee issues.

## ACTS Group on Human trafficking

This Group raises awareness of the extent of human trafficking within Scotland and globally, by giving talks, arranging seminars and conferences. In Scotland, the known number of victims of human trafficking in 2018 was 232, with some living in every local authority.

# **Together Scotland**

Together Scotland is a coalition of Scottish charities that work to improve the awareness, understanding and implementation of the UN Convention on the Rights of the Child (UNCRC). The organisation supported our petition to the Scottish Parliament about military visits to schools and it continues to take up opportunities to raise this issue. As a member of this alliance, we have been working on their Incorporation Strategy Group on the UNCRC (Incorporation) (Scotland) Bill.

Joyce Taylor has reported that our involvement in Together Scotland is through the Parliamentary Engagement Working Group, with Grace Da Costa (BYM staff) and now Andrew Tomlinson, our Parliamentary Engagement Officer, engaging with the organisation. For a wide-ranging group made up of many participants with differing viewpoints, they have managed to keep Quakers informed, and our views and beliefs are often sought after and always respected.

Today, we have heard both enthusiasm, and worry over finances from our Friends giving service on social witness concerns.

We heard from Lynne Barty, newly replaced by Kate Arnot, on Faith in Community Small Grants Committee that there is concern over future finances. We are grateful for Lynne's written report and hope that Kate will find a place going forward within this group, and that funds improve.

Kate then spoke to us of her involvement with the Interfaith Group on Domestic Abuse. She is enthusiastic about working on this group. It has clear aims and is not hindered by the strains of needing to manage property or staff. The Church of Scotland has (pre Covid19) organised a stall on the Sunday of the General Assembly and Kate is always enthused by the interest that the volunteers at the stall receive from the general public. We are reminded that domestic abuse touches people in all walks of life. For further details, please consult ifgoda.org.uk

Kate has also been involved in work on human trafficking for many years. Her work on the ACTS Group on Human Trafficking has been continuing but has reduced due to the transition of ACTS to the Scottish Christian Forum (SCF). Kate is hopeful that this group will begin

meeting again when the SCF is fully set up. Kate is passionate about this work and her role on the group, which is mostly to listen. She is clear that church involvement is important, as it provides an instant community for those who manage to be freed or escape from slavery.

We thank our representatives for the work they do on our behalf, for their written reports, and for speaking to us today.
