12-13 Nov 2011 Edinburgh

Min. 1 Reading

During Meeting for Worship we heard a reading from *Quaker Faith and Practice 23.46* on the need to question some of our assumptions and prejudices regarding social injustices.

Min. 2 Welcome

We welcome 16 attenders to this GM. We also welcome as visitors Paul Parker, Recording Clerk, Michael Hutchison, Assistant Recording Clerk, and Tony Weekes from Ireland YM who is one of our speakers.

Min. 3 Reporter

Min. 5 Financial Policies

Our treasurer John Phillips has presented draft policy statements for our consideration on financial reserves, awarding of grants, and expenses. They are a clarification of existing practice, with the exception that John proposes that we move to gradually reducing our reserves to a level sufficient for about 6 months normal expenditure. We agree to this and to the other statements of policy. The policies will be put onto our website for ease of reference.

Min. 6 Donations

We have considered proposed donations for 2012 and the future. We agree to:

- (a) Increase our donation to Scottish Churches Housing Action from £200 to £300 p.a.
- (b) increase all our other donations by approximately 20%, suitably rounded,
- (c) donate £50 p.a. to the Interfaith Group on Domestic Abuse
- (d) make a one-off donation now of £100 to Quaker Social Action in lieu of expenses of one of our speakers.

Min. 7 Treasurers Conference

John Phillips has put forward a proposal to organise a Treasurers Conference in Scotland sometime in 2012. We warmly support this proposal.

Min. 8 Budget for 2012

John Phillips has presented budget proposals for 2012. He projects an expenditure of £20 500, with projected income of £17 935. This will result in a reduction in our reserves of £2 565 to £15 848.

Proposed donations for 2012, incorporating the decisions taken in Minute 6 above, amount to £5 150. We accept the budget and the proposed donations, and will attach them to these Minutes.

We appoint David Crosbie as Examiner of the accounts until further notice.

Min. 9 Quaker Housing Trust

We have received a report on the work of the Quaker Housing Trust from Jenny Brierley. The Trust is a loan and grant making body which witnesses to the Quaker concern about housing. It does not directly provide housing but supports those who do. It gives grants to smaller projects and loan assistance to larger ones.

Lack of access to adequate housing is an indicator of deep injustices in our economic system. Quaker Housing Trust is supported by voluntary donations and uses these to assist those in acute housing need. They try to support needs to which other organisations find it difficult to respond. They encourage the supported projects to maximise their energy efficiency and sustainability.

The Trust is hoping to expand its work in Scotland. Application proposals for assistance towards projects in Scotland will be welcomed.

Min. 10 Consultation on same sex marriage

We welcome the consultation by the Scottish Government on same sex marriage. Further to GM Minute 7 of 10 Sept 2011, Phil Lucas has presented a draft response to this consultation together with a proposed introductory statement. We have considered the statement, and agree to make the following textual changes: General Meeting - 12-13 Nov in Edinburgh

- (a) In first sentence of paragraph 2, add the word historic so that the sentence reads "The principles of integrity, equality and religious liberty have always been at the heart of our faith, the latter reinforced by our historic experience of being a persecuted minority",
- (b) In first sentence of paragraph 7, change the wording so that the sentence reads "It is fundamental to Friends understanding of the solemnisation of marriage that those who are marrying should make their marriage promises in the presence of God and in front of their worshipping group, seeking God's blessing on their union."
- (c) In the first sentence of the last paragraph, delete the last phrase so that the sentence reads "We do not wish to see our own discernment of what is right imposed on those of other religious faiths."

With these changes, we support the draft response and the statement and ask the Clerk to forward them to the Government on behalf of GM. We thank the Working Group for their diligent and thoughtful work on our behalf.

Min. 11 Economics and the Quaker Way (1)

Our afternoon session has been a consideration of a Quaker approach to economics and society. Tony Weekes held the Ferguson Fellowship in Woodbrooke from 2007-2009 and the document *Economics and the Quaker Way* was the product of his time there.

The Quaker heritage is one of engagement with society, offering a radical vision. Tony emphasised that economics is a social construct derived from human interactions, not a set of immutable laws. The current quantitative approach tends to dehumanise people as 'labour' and is based upon a number of flawed assumptions, including the belief that growth is automatically good.

We should exercise a healthy scepticism - competition is not an end in itself. Tony suggested an economy which respected creation would see solar power as the only reliable source of energy and would recognise the importance of interactions within the eco-systems which maintain life on earth. Human beings have individual abilities, needs and aspirations, and human well-being, rather than growth, should be the objective of the economy.

Annie Miller has described how there has been an increase in inequality within our society with growth benefiting the top 40% and the poorest being no better or worse off. This has occurred through downward pressure on wages and the existence of tax reliefs and loopholes which benefit the rich.

She has spoken in more detail of her concern to promote the concept of a Citizen's Income, a fixed benefit paid to all which would replace existing benefits and tax reliefs. This would avoid the disincentives of means-tested benefits, lengthy form-filling and the mistrust of claimants. By removing tax reliefs for the rich it would help to reduce inequality. Annie provided an example of how such a scheme might work.

We have explored through questions aspects of the Citizen's Income proposal, and encourage Annie to proceed with this work. We should not be afraid of appearing idealistic when our political scene is so lacking in vision. We thank Tony and Annie for their contributions this afternoon.

General Meeting – 12-13 Nov in Edinburgh

We have also heard something of the response of the Economic Sustainability and Peace Sub-Committee of QPSW to the Occupy demonstrations.

In our discussion we have ranged over various topics including the need for housing development on brownfield sites; empty properties and ownership of second homes; and the problem of vested interests. We recognised the need for international co-operation on many financial issues.

Some Friends are involved in local co-operatives and credit unions. We can make a difference by choosing institutions for investment and banking which operate on ethical principles. There is also value in working together with other churches and faiths, and with other bodies working for economic reform.

In Scotland, the most productive action we as Quakers can take as a group might be to seek to influence the Scottish Government as it pursues increasing fiscal autonomy.

Min. 12 Economics and the Quaker Way (2)

We have continued our discussion on Sunday morning, seeking to understand how the principles of our Quaker faith should lead us to contribute through testimony and personal action to the reformation of our current economic system. We note that Britain Yearly Meeting is supporting the campaign to introduce a tax on financial transactions, the Tobin Tax. We have identified a number of contributions we can make individually, bearing witness to a less materialist lifestyle and ensuring that our savings are put to productive use.

Within the debate which is taking place in our wider society, including the Occupy demonstrations, we see the need to uphold a non-violent approach and to work in a constructive way with other faiths and like-minded groups. We see the increasing inequality in our society and the growth of unemployment as a challenge both to our Quaker principles and to social stability.

We are called to go into the silent worship of our Meetings, to listen for God's guidance, to discern how best each of us can respond to this great challenge of our time, and how, by being ourselves transformed, we can contribute to the transformation of our world.

We record our thanks to South East Scotland Friends for being our hosts at this GM, and look forward to meeting again in Perth on 3 March 2012 when our speaker will be Katie Frost from Friends House on links between local Meetings and work done centrally on our behalf.
